Our **GDPR Enhanced Audit** is a fuller version of our Basic Audit. In addition to access to our Basic online audit tool, we will have an initial meeting with you to discuss concerns and provide advice. As part of this Enhanced Audit we shall also review your current key contracts and policies*, and provide guidance on GDPR related issues that may need to be addressed.


Our **GDPR Advanced Audit** is the most comprehensive of our audits. With this option, you will benefit from everything included in our Enhanced Audit, plus our experienced team will provide guidance on GDPR related issues in a follow up meeting with you, and advise on and assist with implementing any necessary changes to your current key contracts and policies* to address GDPR requirements.
